Projects:

We have the materials for the filter media ordered and are waiting on the first shipment. We will store these here while waiting on the rest of the media. We only have one customer left to change to get the full district on auto read.

This is an 1 ¹/₂" meter at Pensacola Fire Dept.

The line relocation project for Hwy 28 and 440 rd. has the casing in place, and the 4" water line pulled through. The line at Hwy 28 and 439 rd. going south has the casings in place and the 4" line pulled through. They are now working on the 2" line relocation at Hwy28 and 439 rd. going north. I expect this whole project will be finished within a couple of weeks. We have also been notified by ODOT that the line relocation from Pensacola to Langley has been approved and is ready to go out for bids.

Last month we repaired 6 water leaks, changed 2 regulators, set 2 meters, moved 0 meters, replaced 1 meter cans, changed 2 cut-off valves, changed 1 smartpoints, and processed 42 locates. The total water loss for last month was 57%, and the adjusted after leak repairs was 52%. We are a just about caught up on repairing leaks. We will continue to look for loss in the district.
